2022 Arbourgate Pool Rules

The Arbourgate swimming pool is a community pool, entirely funded by homeowner assessments. The Arbourgate Board of Directors administers the pool rules. The service of the pool is the responsibility of Aquatech Pool Management Company.

The pool will be open **Sunday May 1, 2022**, through **Friday, September 30, 2022**, from sunrise to sunset.

- Admittance to the pool is for Arbourgate homeowners who are in good standing and their guests.
- Homeowners must use their key to enter the pool deck.
- All residents are required to familiarize themselves and their guests with the pool rules.
- Gates to pool may not be propped open.
- No running, pushing, horseplay, dunking, or holding people under water.
- Diving is not permitted anywhere in the pool.
- No loitering in the bathrooms.
- No glass bottles or other glass objects are permitted in the pool or on the pool deck.
- Intoxicated behavior will not be tolerated. Persons exhibiting intoxicated behavior will be asked to leave the premises. An incident report may be filed which may lead to a suspension of pool privileges.
- No smoking or vaping on the pool deck or in the pool.
- Food is not permitted in the pool and must be consumed away from the perimeter of the pool.
- All residents and their guests are responsible to clean up after themselves before leaving the pool.
- Water wings, small flotation devices, and small inflatable toys are permitted.
- No pets, bicycles, skateboards, scooters, or rollerblades are allowed on the pool deck at any time.
- No person is allowed to swim with an open wound or an eye or skin infection.
- Any person who is incontinent or not fully potty-trained must wear appropriate waterproof clothing or swim diapers while in the pool.
- Residents who have had their amenity privileges revoked may not enter the pool area as guests.
- Foul and abusive language will not be tolerated and are grounds for expulsion from the pool. An incident report may be filed which may lead to a suspension of pool privileges.
- The Pool Managers are responsible for enforcing the Pool Rules for your safety, health, and comfort. This includes closing the pool for emergencies including weather, maintenance, and sanitation.
- The Board of Directors have the authority, when deemed necessary, to expel or revoke access anytime for misbehavior, use of abusive language or apparent intoxication. To file a written complaint, contact Cusick Community Management.
- The health and safety of the members and their guests are ultimately their own responsibility and pool users use the pool at their own risk.
- The Arbourgate Neighborhood and Board of Directors are not responsible for the loss or damage of personal property.
- Only balls made of soft material are allowed in the pool. Do not throw balls such as baseballs, footballs, etc., at one another.
- Large floats will only be allowed during non-peak times.
